Subject: Revision of pension of pre-2006 pensioners – Modalities for Payment of Arrears - Reg. Need for Clarification

Reference: DoP&PW OM No.38/37/08-P&PW(A) Dated 30.7.2015 and dated 28.1.2013

1. Orders of DOP&PW dated 30-7-2015 cited above, inter alia provide as under vide Para 4 thereof:

“----- it has been decided that the pension/family pension of all pre-2006 pensioners/family pensioners may be revised in accordance with this Department's OM No.38/37/08-P&PW(A) dated 28.1.2013 with effect from 1.1.2006 instead of 24.9.2012.”

2. While thanking the Govt. for providing the much awaited relief to the affected pre 2006 Pensioners, we would like to mention the following problems regarding early implementation of the said orders – thereby further delaying the awaited relief:

i) Many of the Pre 2006 Pensioners have not been issued the Revised PPOs in spite of a lapse of nearly 7 years since implementation of Sixth CPC;

ii) Many of the affected Pensioners have not been issued (Re)-Revised PPOs as per OM dated 28-1-2013 and have not been paid the arrears by the PDA Banks even from 24-9-2012, in the absence of (Re)-Revised PPOs or for reasons best known to PDAs;

iii) OM dated 30-7-2015 cited above did not specify that the PDA Banks should pay the arrears from 1-1-2006 forthwith to the affected Pre 2006 Pensioners. (all that it said was that *“All pension disbursing offices are also advised to prominently display these orders on their notice boards for the benefit of pensioners.”* This needs to be supplemented with instruction reg. early Payment of Arrears by the PDA Banks to the affected Pensioners/Family Pensioners.


3. It is requested that necessary instruction may please be issued to all concerned reg.:

i) Pension Sanctioning Authority (PSD) should issue the Revised/Re-Revised PPOs to all Pre 2006 Pensioners/Family Pensioners wherever not done so far – keeping in view the DoP&PW's OMs dated 30-7-2015 cited above;

ii) All Pension Disbursing Authorities (PDAs) – Banks – should Pay the Arrears from 1-1-2006 of the Pension/ Family Pension forthwith, where ever due in terms of DOP&PW OM dated 30-7-2015 read with OM dated 28-1-2013.
